

**CITY OF JAMAICA BEACH  
RESOLUTION 2018-4**

**A RESOLUTION OF THE CITY OF JAMAICA BEACH, TEXAS,  
ESTABLISHING THE PARK PAVILION PERMIT FEES.**

**WHEREAS**, the City Council of the City of Jamaica Beach, Texas, adopted Ordinance 2018-5 providing city park locations, issuance of park permits, park restrictions and prohibited acts; providing violations and penalties; providing for the repeal of all or parts of Ordinances in conflict herewith; providing for severability; and providing for an effective date, as amended, to provide more effective and efficient policies and procedures related to park pavilion permits and fees; and

**WHEREAS**, Ordinance 2018-5 states in Section 2(3)(D)(i)(ii), the City Council shall have the authority to establish, alter and/or enforce the pavilion permit fees, as deemed necessary, by adoption of a City of Jamaica Beach Resolution; and

**WHEREAS**, the City Council has decided it is in the best interests of the citizens of the City of Jamaica Beach to adopt this Resolution establishing the park pavilion permit fees.

**NOW, THEREFORE, BE IT RESOLVED**, the City Council of the City of Jamaica Beach, Texas, set the following permit fees to use the park pavilion:

1. Permit for Use of Park Pavilion:

(i) Permit for use of park pavilion Friday – Saturday with:

- a. 0-99 guests require a security deposit of two hundred fifty dollars (\$250) and rental fee of one hundred fifty dollars (\$150);
- b. 100-199 guests require a security deposit of four hundred dollars (\$400) and rental fee of two hundred fifty dollars (\$250);
- c. 200+ guests require a security deposit of six hundred dollars (\$600) and rental fee of three hundred fifty dollars (\$350).

(ii) Permit for use of park pavilion Sunday - Thursday with:

- a. 0-99 guest requires a security deposit of two hundred fifty dollars (\$250) and rental fee of seventy-five dollars (\$75);
  - b. 100-199 guest requires a security deposit of four hundred dollars (\$400) and rental fee of one hundred dollars (\$100);
  - c. 200+ guest requires a security deposit of six hundred dollars (\$600) and rental fee of one hundred twenty-five dollars (\$125).

2. Permit for Use of Park Pavilion-Charitable Event:

- (i) Permit for use of park pavilion for any type of Charitable Event:
  - a. Requires a security deposit of two hundred fifty dollars (\$250) and rental fee of two hundred fifty dollars (\$250);
  - b. Charitable Organizations and/or Non-Profit Events must provide proof of 501(c)(3) exemption with "Charitable Event" permit application.

3. Permit for Use of Park Pavilion-Special Event:

- (i) Permit for use of park pavilion for any type of Special Event:
  - a. Requires a security deposit of two hundred fifty dollars (\$250) and rental fee of five hundred dollars (\$500) for eight (8) consecutive hours; plus twenty-five dollars (\$25) for each additional hour;
  - b. Events that are open to the public and/or selling merchandise/goods for profit require a "Special Event" permit application.
