CITY COUNCIL REGULAR MEETING MINUTES

February 27, 2023 6:00 P.M.

<u>Kaylynn Williford</u>: 16714 Marina – Agenda items 9 & 10. Wanted to clear up some confusion as to where the no parking signs will go, from Flamingo Way and back to the end of Bob Smith. Couple of reasons this is important, to stop people from cutting the fence, disturbing the marsh grass and keep unwanted trash from all along Bob Smith. Will not prohibit people from seeing the sunsets or sitting in the golf carts fishing, just help stop cars left unattended.

<u>Debra Tabbert:</u> 16916 Beachcomber – Agenda items 7 & 10. The dog park, thinks it's a great idea, something we've needed in our community, and can possibly use some of the Hot Tax money for the expense. Branch Construction, and there's nothing for free, looked back in our check register and we've spent almost \$115,000.00 since October 2022 with little oversite from council, if these are truly emergency repairs, we have bigger problems than any of us know.

Alderman Madray read his report on the dog park. At the meet the candidates when I ran for office there was a lot of political talk about a Dog Park. I liked it then and I like it even better now. I'm proposing that we use the City property at the Waste Treatment Plant for the Dog Park. There is enough area for parking and a good-sized Dog Park. The city of

Galveston has several dog Parks that are smaller. We can do this cost efficiently, site prep and fencing, with hot tax money. This would allow for the \$107,200.00 dollars of property tax money, that's in the Budget now for bulkhead work down there, to be used for priority infrastructure needs. Amenities like this Dog Park are what make a community a community and speak volumes about what kind of town I want us to be. We are early in this discussion. I move that this discussion be tabled until the next council meeting at which time I will present a concept plan for council and staff consideration and action.

11. MAYOR'S REPORT:

Mayor Morris reported that the city has been monitoring water usage and water loss, and doesn't feel like we need to spend a lot of money on testing and measuring, it's pretty simple when water is shooting out of the ground, we know it needs to be fixed. Thanked Director of Operations for his hard work on daily responsibilities, and he's the guy to get grants and federal funding. The process with Branch was followed as instructed by council correctly and he had the approval to negotiate with them. Thanked the beautification committee again for all the work they have done, its been a great positive experience. Thanked Branch Construction for all the work during the holidays and during the freeze shutting off water to homes at no cost to the city, cleaning the drainage ditches and for the concrete labor behind city hall. "Will continue doing upgrades and repairs within the city, it's a slow process, but we are working toward a solution. About to start taking bids on phase 4 of the waterline replacement project. Remember I am a phone call away and so are staff."
