## CITY COUNCIL REGULAR MEETING MINUTES

June 20, 2022 6:00 P.M.

#### **CALL TO ORDER AND ROLL CALL OF MEMBERS:**

<u>Andrea Spearing</u> - 16617 Jamaica Beach Road – Addressed the agenda item about Hazard Mitigation and a plan to be able to act quickly, possibly have an onsite response dispatch system during the busy season.

#### REPORTS FROM DIRECTORS, POLICE, AND FIRE:

Director Nesbitt reported the new city park equipment installation will begin on July 5 and will take approximately three to five days to complete, the company will take down and haul away

the debris. Updated everyone on city pool issues, "have changed companies who maintain the chemicals at the pool, and this should take care of the unexpected closures. Both flag poles in front of City Hall have been repaired and new flags installed. Budget time is here, will be scheduling workshops for the FY 2022/2023 budget."

Director Heiman gave his report on citations issued in the month of May 2022 and over memorial weekend, total issued were 224 citations and 103 were over the memorial weekend. Reported that the city is on the Galveston PD CAD system, and "we contract with Galveston County for dispatch services, and we have a dedicated dispatch number (409) 737-1800 and there is no time lapse in dispatch services, and this number is 24-7 and citizens can call this number regular hours."

#### COMMENTS / REPORTS FROM MEMBERS OF COUNCIL:

Alderwoman Jones: Attended the West Galveston Island Property Owners Hurricane Meeting last Saturday and took video and put it on Face Book and YouTube, "before and after the meeting I shared Stars for Troops and gave constable Jimmy Fullen about 150 stars that he will be sharing with the Border Patrol officers. A lot of first responders attended the meeting as well and I gave out as many stars as I could, found a few veterans one the Korean War, and several Vietnam vets. One of our citizens went to the Naval Academy Submarine division school in South Carolina and watched her grandson graduate and gave out over one hundred stars. Reported that over 3500 hundred starts have been shared, thanked all the helpers with the Stars for Troops program. Also attended the JBIC meeting and took video and put on YouTube and Face Book."

Alderman Welch: no report Alderman Green: no report

Alderman Madray: Reported that "Don Towner is getting bids to replace the palm trees along Buccaneer and to rework the flower beds and I should have prices next week. Council has a lot to talk about, budget, second quarter financial reports will be a good way to start, a user fee beach plan, standard operating procedures, Municode, these are things we need to work on. June 15, 2022, I talked with Carver Wray the project manager with Costal Erosion Planning & Response Act, and he verified that the Core of Engineers has issued the permit to GLO that is required for CEPRA to start the beach replenishment planning for our beach, and we should have approval sometime in September and the process will take about 11 months to complete, so maybe by next October."

MPT Rupertus: Welcomed Alderman David Welch back to council, will be a huge asset to council. "Also attended the hurricane meeting, did not video tape it, but basically what came out of that meeting is be prepared, pack up and get out, get off the island. They do not have as much staffing, equipment, or vehicles as they've had in previous years, police vehicles and fire trucks are two years back ordered and if we do have a disaster, it will take first responders longer to respond, just need everyone to have a plan be prepared and leave, get someplace safe." JBIC meeting is cancelled and the next one will be in July.

Mayor Morris stated that council discussed a lot of his items. Budget workshop meeting are coming. Made a statement about the hurricane meeting, basically said get out and be safe, we could have some serious incidents, and could be catastrophic.

Then those ideas are written into ordinances and or budget for implementation. Please remember most of our improvements in our city has started with citizens and their ideas and we as your elected officials look forward to always hearing from you all at any time.
