PUBLIC COMMENTS FROM TOWN HALL MEETING

<u>Debra Tabbert</u>, 16916 Beachcomber, Stated "We all need help, no one communicates with the residents of Beachcomber. Stated "I made a call to GLO asking if there was anything in the works or permits issued to do drainage work on Beachcomber. The drainage issue started from hurricane like, when the drainage was washed away, we need a solution to our drainage problems and the City's help and be willing to dedicate to finding a solution and please communicate with us."

Larry Barsfield, 16922 Beachcomber, wanted to applaud the city for updating the City's web-site, worked as a web designer for years and would recommend changing the appearance every 6 months to a year, to keep people interested. Stated "I've lived on Beachcomber for about 10 years and did some research on a meeting with GLO about the original plan and drainage that didn't work, those pumps clogged up in about 6 months for lack of maintenance and staff to maintain those pumps. The city needs to budget each year for regular routine maintenance. I looked over the engineer's plan and on page 37 is a diagram that shows during the road project drainage will be added."

<u>Bob Sark</u>, 16924 Beachcomber, Stated "I've lived on Beachcomber for 21 years and we've never has anyone, but Russell helped, he cut drainage a couple times, but we need some help to get the water out of the streets, I can't walk down the street without getting my shoes wet. Hopefully the City is working on a plan to help."

<u>Ginger Jones</u>, 16612 Curlew, Asked about the LTR and STR Ordinances, if the attorney approve it. Worked with JBIC on the flags for Stars for Veterans. Asked everyone to please come out and vote at the Seaside Church. Thanked Mayor for having a TOWN HALL MEETING.
