CITY OF JAMAICA BEACH, TEXAS MINUTES OF THE REGULAR CITY COUNCIL MEETING April 19, 2021

The City Council of the City of Jamaica Beach, Texas, held a regular meeting on Monday, April 19, 2021, at City Hall, 16628 San Luis Pass Road, Jamaica Beach, Texas. Members of the public were invited to attend the meeting in person or by video or audio conference.

With a quorum of the Council Members present, Mayor Spicer called the meeting to order at 6:00 p.m. followed by the pledge of allegiance to U.S. and Texas flag.

PUBLIC COMMENTS

Ginger Jones made the following comment; "In reading over the parking ordinance there are a lot of streets with parking problems. Maybe we should consider restricting parking during certain hours. I know our street has had parking problems. I know that there are certain streets that need it more, but maybe we should consider the parking problems throughout the City."

CONSENT AGENDA

- 1. Approval of the minutes of the Regular City Council meeting on March 15, 2021.
- 2. Approval of the September, October, November, December 2020, January and February 2021 General Fund Financial Reports.

A motion was made by Alderman Rizzo to approve the Consent agenda item #1 (approval of minutes) and Alderman Rupertus seconded the motion. The vote to approve the motion was unanimous.

A motion was made by Alderman Rupertus to table agenda item # 2 (GF Financials) and Alderman Morris seconded this motion. The vote to table the agenda item was unanimous.

REGULAR AGENDA

1. Discussion and possible action to accept the increased access line rates from the Public Utility Commission of Texas.

A motion was made by Alderman Rupertus to accept the increased line rates from the PUC of Texas. Alderman Morris seconded the motion. The vote to approve the motion was unanimous.

 Discussion and possible action to adopt an ordinance AMENDING ORDINANCE 87-4; PROVIDING FOR ADDITIONAL NO PARKING STREETS DEEMED NECESSARY TO PROMOTE THE HEALTH, SAFETY, AND WELFARE OF THE PUBLIC; PROVIDING FOR THE REPEAL OF ALL OR PARTS OF ORDINAINCES IN CONFLICT HEREWITH; AND PROVIDING FOR AN EFFECTIVE DATE.

A motion was made by Alderman Rupertus to approve the amended ordinance as stated. Alderman Rizzo seconded the motion. The vote to approve the motion was unanimous.

3. Discuss and consider action to approve the new City Personnel Policy.

A motion was made by Alderman Hoffman to table the approval of the City Personnel Policy. Alderman Rupertus seconded the motion. The vote to approve the motion was unanimous.

REPORTS

CITY ADMINISTRATOR

Brad Heiman, Interim City Administrator, reported he will be reviewing all ordinances for needed updating and revisions and will be presenting the amended revisions to Council at later dates. He also reported that the Winter Storm Claim was pending additional action and there has been no changes as to the additional categories of loss by FEMA at the time of this report.

MAYOR

Mayor Spicer reported that this meeting would be his last full meeting and he thanked all members of the Council for their hard work and dedication to Council.

<u>ALDERMEN</u>

MPT Green thanked the Mayor and advised that he was sorry to see him go.

Alderman Hoffman reported that the Easter event had a great turnout and there were plenty of eggs for all the kids. She also thanked everyone for helping set up and clean up after the event. She advised that she was getting inquiries as to a Memorial Day event and invited anyone with input to contact her and she would "see what we should do" about the event for this year.

Alderman Rizzo reported that she attended the JBIC meeting, however there was nothing to report.

Alderman Morris gave "thanks" to the Mayor for everything he has done for the "great City of Jamaica Beach and then reported that he was going to focus on ordinance updates, beach access, and enhanced communications on all levels for the Council and City.

Alderman Rupertus advised that if anyone cared to comment on the FM 3005 work project they could reach out to the City of Galveston, Texas DOT, or Angel Brothers Construction. He further reported that he had been getting comments about the confusion as to beach access from citizens. Additionally he added that he thought Spring Break was a he success and there were no complaints about excessive speeding or vehicles. He added that he wanted to give a "shout out" to Brad, John and the PD staff for staying on top of the beach. He then stated that he believed that "we are going in the right direction" in regard to the beach.

Alderman Rupertus added that the Marina is another "hot topic" and that he led the fight and worked diligently on the Marina plan. He invited anyone with comments or complaints concerning the Marina to contact him. He closed the Marina comments by stating that we have done a good job in cutting down outside traffic tremendously at the Marina. The Alderman Ruptertus then advised everyone to pay close attention to the new tax appraisals and that he urged everyone to make comments (citing two ways to do so). He closed his report out by stating that there was a really important election coming up and recommended that everyone do their due diligence in casting a vote.

POLICE

John Aucoin, Interim Police Chief gave a brief summary of the report. He reported Projects Pending:

1. Body Worn Cameras:

We are continuing to evaluate the BWCs and will be forwarding a report of the findings to the Council and City Administrator.

2. League City Consortium:

We have had several meetings with the LCC in reference to having to change software program vendors due to the fact that the current vendor's program is no longer being supported with needed updates. This affects about (15) different agencies and everyone is working on finding other vendors to contract with for the near future. The costs for the new vendor will be on a "scaling system" depending on the size of the agency.

Police Activity: .

In March we had 11 new cases opened for various issues.
