CITY COUNCIL REGULAR MEETING MINUTES

September 19, 2022 6:00 P.M.

CALL TO ORDER AND ROLL CALL OF MEMBERS:

With a quorum of the Council Members present, Mayor Morris called the meeting to order followed by the pledge of allegiance to the U.S. and Texas flags lead by Alderman Welch.

Sharon Bower – 16720 Sandpiper – Addressed Mayor and Council about Local Government Code Chapter 171, concerning and regulating Conflict of Interest and how it effects elected officials, and she objected to MPT Rupertus, who owns Westend Maintenance, be able to vote on the budget.

REPORTS FROM DIRECTORS, POLICE, AND FIRE:

Director Quintero stated "if you drive through the city, things are getting done, street signs are going up, go look at the park is getting cleaned up, parking lots are getting repainted, we are getting a lot of the projects done. Potholes are being repaired, just be patient with us, things will get addressed and done."

City Secretary Nesbitt reported that she contacted, Katherine Overbeck Maxwell, and set the annual audit for December 5, 2022. Had a conference call with City Attorney's and Civic Plus to finalize the recodification project of our Cities Ordinances. Reported to install a microphone on the desk, will involve getting a new amplifier box. Gave an update on HOT tax collected \$781,751.06, Property Taxes \$885,800.58 and court fines collected of \$32,828.62.
