

**CITY OF JAMAICA BEACH  
ORDINANCE NO. 2023-09  
TAX RATE FOR THE 2023-2024 FISCAL YEAR**

**THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.**

**THE TAX RATE WILL EFFECTIVELY BE RAISED BY 3.50 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$-26.02**

**AN ORDINANCE OF THE CITY OF JAMAICA BEACH, APPROVING AND LEVYING THE AD VALOREM TAX RATE OF \$0.139594 PER ONE HUNDRED DOLLARS (\$100.00) OF ASSESSED VALUATION OF ALL TAXABLE PROPERTY WITHIN THE COPRATE LIMITS OF THE CITY FOR THE USE AND SUPPORT OF THE MUNICIPAL GOVERNMENT OF THE CITY OF JAMAICA BEACH, TEXAS FOR THE 2023-2024 FISCAL YEAR. MAKING VARIOUS FINDING AND PROVISIONS RELATING TO THE SUBJECT; FINDING COMPLIANCE WITH THE OPEN MEETINGS LAW; AND PROVIDING AN EFFECTIVE DATE HEREOF.**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF JAMAICA BEACH:**

**WHEREAS** a budget appropriating revenue generated for the use and support of the municipal government of the City of Jamaica Beach, Texas has been approved and adopted by the City Council as required by Chapter 102 of the Texas Local Government Code; and

**WHEREAS** the City approved a proposed tax rate on September 14, 2023; and

**WHEREAS** the City Council finds that it is necessary and proper for the good government, peace and order of the City to adopt an Ordinance establishing an ad valorem tax rate.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JAMAICA BEACH, TEXAS, THAT:**

**SECTION 1.** That upon all personal, real, and mixed property, owned and situated within the territorial limits of the City of Jamaica Beach, Texas on January 1, 2023, and not exempt from taxation by such City under the Constitution and Laws of the State of Texas, there shall be and there are hereby levied for the fiscal year beginning October 1, 2023, annual ad valorem taxed

for the maintenance, operation and support of the general government (general fund) at the rate of \$0.139594 upon each \$100.00 dollar valuation, 100% of such property.

**SECTION 2.** This Ordinance shall be and become effective from and after it is adoption.
