

**CITY OF JAMAICA BEACH
ORDINANCE 2023-03**

AN ORDINANCE OF THE CITY OF JAMAICA BEACH, TEXAS, AMENDING ORDINANCE NO. 2021-05; THE ESTABLISHMENT OF THE RESERVE POLICE FORCE FOR THE CITY OF JAMAICA BEACH, TEXAS; PROVIDING THE METHODS AND STANDARDS FOR APPOINTMENT OF RESERVE POLICE OFFICERS; PROVIDING THE AUTHORITY OF THE RESERVE POLICE OFFICER; PROVIDING OTHER PROVISION RELATING TO THE SUBJECT; PROVIDING FOR THE REPEAL OF ALL OR PARTS OF ORDINANCES IN CONFLICT HERewith; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JAMAICA BEACH, TEXAS, AS FOLLOWS:

SECTION 1. There is hereby authorized the establishment of a reserve police force for the City of Jamaica Beach, Texas. The number of Reserve Police Officers shall not exceed thirty (30).

SECTION 2. The Chief of Police shall appoint members of the reserve police force.

SECTION 3. Reserve Police Officers shall act only in a supplementary capacity to the regular police force. Reserve Police Officers may be called into service by the Chief of Police when he, in his discretion, considers it necessary to have additional officers to preserve the peace and enforce the law. When called into service, a Reserve Police Officer shall serve as a Peace Officer during the actual discharge of official duties.

SECTION 4. A Reserve Police Officer must fulfill the minimum training standards established for all Reserve Law Enforcement Officers by the Texas Commission of Law Enforcement. Reserve Peace Officers shall further possess and maintain the minimum physical, mental, educational, and moral standards established for all Peace Officers established by the Jamaica Beach Police Department Standards of Operation and the Texas Commission on Law Enforcement.

SECTION 5. Reserve Police Officers shall serve without compensation.

SECTION 6. All Ordinances or parts thereof in conflict herewith are repealed to the extent of such conflict only.

SECTION 7. This Ordinance shall be and become effective immediately.
