The 2020 US Census reports the population of Jamaica Beach as 1,078.

634 households and living arrangements.

1,410 housing units.

57.4 % have a Bachelor Degree or higher.

Median age is 56.7.

26.8 % are over the age of 65.

5 % are over the age of 75.

37 people or 8.8% live below the poverty line.

96.2% are U.S. citizens.

9.5 % were born in a foreign country.

4.9 % served in the military. The majority of those served in Vietnam.

66.9% drive alone to work.

29.2 % work from home.

3.9 % carpool.

57.1% are employed.

I went back and found an old Public Information Request that shows 299 new house construction permits from 1997 to 2021. We gained 299 more homes but maintained about the same amount in population over the years.
