# CITY COUNCIL REGULAR CALLED MEETING MINUTES

FEBRUARY 20, 2017 6:00 P.M.

- 1. CONSIDER FOR ACTION A BID TO REPAIR THE BULKHEAD ON TERN DRIVE. Alderman Green motioned to award the bid to Island Marine Pile Drivers. Second by Alderman Hudson. Motion unanimously approved by those present.
- 2. CONSIDER FOR ACTION THE STREET REPAIRS ON JAMAICA COVE AND BUCCANEER. Alderman Hudson motioned to approve Lucas Construction to do the street repairs on Jamaica Cove and Buccaneer. Second by Alderman Kurtz. Motion unanimously approved by those present.
- 3. CONSIDER FOR ACTION DESIGNATING A DOG PARK AREA AT THE CITY PARK. Alderman Green motioned for the item to be Tabled until April's Council Meeting. Second by Alderman Hudson. Motion unanimously approved by those present.
- 4. CONSIDER FOR ACTION A VARIANCE REQUEST TO ALLOW AN 8 FT. SIDE SETBACKS ON THE PROPERTY LOCATED AT 16702 SANDPIPER. Alderman Green motioned to approve the variance request to allow 8 ft. side setbacks on the

  - a. CHANGE SIDE AND FRONT PROPERTY SETBACKS TO ALIGN WITH JBIC'S SETBACKS.
  - b. ALLOW EXTERIOR STAIRWAYS TO EXTEND 4 FEET INTO SIDE SETBACKS.
  - c. ALLOW CARGO LIFTS IN SIDE SETBACKS WITH AN APPROVED VARIANCE OR AS A MEDICAL NECESSITY.

Alderman Green motioned to conduct a Public Hearing on April 3, 2017 to discuss amendments to the Zoning Ordinance, removing item b., because the Zoning Ordinance already allows it. Second by Alderman Hudson. Motion unanimously approved by those present.

8. CONSIDER FOR ACTION A PROCLAMATION DECLARING MARCH 28<sup>TH</sup> AS BLIND VETERANS DAY IN THE CITY OF JAMAICA BEACH.

Alderman Green motioned to approve the Proclamation declaring March 28<sup>th</sup> as Blind Veterans Day in the City of Jamaica Beach. Second by Alderman Lindley. Motion unanimously approved by those present.
