CITY COUNCIL WORKSHOP MEETING MINUTES

MARCH 5, 2012 6:00 P.M.

CALL TO ORDER

Mayor Pierson called the meeting to order.

PLEDGES OF ALLEGIANCE TO THE U.S. AND TEXAS FLAGS

MPT Burke led the Pledges of Allegiance to the U.S. and Texas Flags.

ITEMS OF BUSINESS:

1. DISCUSS AMENDING ORDINANCE 87-4, AN ORDINANCE ESTABLISHING ADDITIONAL NO PARKING STREETS, TO INCLUDE ADDITIONAL NO PARKING SIGNS.

City Administrator Brick said the amendment pertained to No Parking on Jamaica Beach Road to help the Police Department deal with the overflow from the beach. Mayor Pierson asked City Administrator Brick if any of the Jamaica Beach Road residents had any objection to the No Parking amendment. Mr. Brick replied no. Alderman Montgomery inquired about guest parking on Jamaica Beach Road that are visiting resident's with smaller driveways. Mayor Pierson suggests waiting until after the city adopts their Beach Access Plan before voting on the amendment. He opened the item for discussion:

Steve Spicer, 16502 John Davis, inquired about possibly making beach access parking larger.

Danny James, 16701 Kingston Way, said he has had beachfront homeowners complain to him about people parking in front of their houses.

2. DISCUSS APPROVING A CERTIFICATE OF RECOGNITION FOR STEVEN SPICER AND RICK PRICE.

Mayor Pierson read the Certificate of Recognition for Steve Spicer and Rick Price. He congratulated Steve and Rick for their years of service.

3. DISCUSS TRANSFERRING BUDGET FUNDS FROM 13014-DRAINAGE MAINTENANCE TO 13018-BULKHEAD MAINTENANCE FOR REPAIRS TO BULKHEAD AT BOAT LAUNCH AREA AND SLIPS.

City Administrator Brick explained the \$12,000 budget transfer. He said the request is just a transfer of funds from one account item to another and not an increase to the budget.

4. DISCUSS POLICE DEPARTMENT RACIAL PROFILE REPORT. Police Chief McLane explained the Racial Profile Report to Council.

Alderman South motioned to transfer \$12,000 budgeted funds from 13014-Drainage Maintenance to 13018-Bulkhead Maintenance for repairs to bulkhead at boat launch area and slips. Second by Alderman Montgomery. Unanimously approved.
