CITY COUNCIL SPECIAL REGULAR MEETING MINUTES

APRIL 15, 2019 6:00 P.M.

CALL TO ORDER

MPT Sherwood Green called the meeting to order.

PUBLIC HEARING:

1. THE CITY COUNCIL OF THE CITY OF JAMAICA BEACH WILL HOLD A PUBLIC HEARING ON PROPOSED AMENDMENTS TO THE DUNE PROTECTION AND BEACH ACCESS PLAN FOR THE CITY OF JAMAICA BEACH.

MPT Green read the above Public Hearing Notice then asked Police Chief Heiman to explain the proposed amendments to the Dune Protection and Beach Access Plan. Police Chief Heiman explained the following: current restricted areas on the beach are noncompliant with the GLO; proposed plan to remove the existing bollards between the two beach access points to allow the flow of traffic; designating ½ of the beach as restricted and ½ for parking; the holiday parking schedule was added, noted no changes to the schedule; rules the city/police must follow pertaining to beach closures; public beach access rights and requirements; current safety concerns; the amendment process, noted the proposed

amendments must be approved by the GLO before the Dune Protection and Beach Access Plan is officially adopted.

- 1. CONSIDER FOR ACTION APPROVING THE FOLLOWING MINUTES:

Alderman Rupertus motioned to approve the above listed minutes. Second by Alderman Welch. Motion unanimously approved by those present.

- 2. CONSIDER FOR ACTION DESIGNATING CITY FUNDS TO UTILIZE THE GALVESTON COUNTY MOBILITY BOND CASH MATCHING COMPONENT FOR ADDITIONAL STREET IMPROVEMENT PROJECTS.
 - Alderman Welch motioned to approve the city designating city funds to utilize the Galveston County mobility bond cash matching component for additional street improvement projects by approving an Interlocal Agreement between the Galveston County and the City of Jamaica Beach. Second by Alderman Kurtz. Motion unanimously approved by those present.
- 3. CONSIDER FOR ACTION APPROVING AN ENGINEERING AGREEMENT BETWEEN THE CITY OF JAMAICA BEACH AND JOHN D. MERCER & ASSOCIATES FOR PROFESSIONAL SERVICES FOR THE 2019 WATER LINE REPLACEMENT PROJECT, IN AN AMOUNT NOT TO EXCEED \$30,000, FUNDING FROM 20005 MAIN WATER LINE EXPENSES.
 - Alderman Kurtz motioned to approve an Engineering Agreement between the City of Jamaica Beach and John D. Mercer & Associates for Professional Services for the 2019 Water Line Replacement Project, in an amount not to exceed \$30,000, funding from 20005 Main Water Line Expenses. Second by Alderman Rupertus. Motion unanimously approved by those present.
- 4. CONSIDER FOR ACTION APPROVING THE BID FROM JM SALES & SERVICES, INC. FOR THE MARINA PAVING PROJECT & STREET TRANSITION IMPROVEMENTS PROJECT, IN THE AMOUNT OF \$28,283.75 FOR BOTH PROJECTS, FUNDING FROM 13012 STREET M&R AND 13018 BULKHEAD M&R.
 - Alderman Welch motioned to approve the bid from JM Sales & Services, Inc. for the Marina Paving Project & Street Transition Improvements Project, in the amount of \$28,283.75 for both projects, funding from 13012 Street M&R and 13018 Bulkhead M&R. Second by Alderman Rupertus. Motion unanimously approved by those present.
- 5. CONSIDER FOR ACTION APPROVING AN ORDINANCE OF THE CITY OF JAMAICA BEACH, TEXAS, AMENDING THE DUNE PROTECTION AND BEACH PLAN OF THE CITY OF JAMAICA BEACH, AS AMENDED, TO PROVIDE ADDITIONAL DEFINITIONS, AND STANDARDS FOR REGULATING ACCESS AND PARKING ON THE BEACH; TO PROVIDE VIOLATIONS AND PENALTIES; TO PROVIDE FOR SEVERABILITY; TO PROVIDE FOR THE REPEAL OF ALL OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE.

Alderman Kurtz motioned to approve the above stated ordinance. Second by Alderman Rupertus. Motion unanimously approved by those present. Creating Ordinance 2019-2.
