# CITY COUNCIL SPECIAL WORKSHOP MEETING MINUTES

APRIL 16, 2012 6:00 P.M.

#### **CALL TO ORDER**

Mayor Victor Pierson called the meeting to order.

### **ITEMS OF BUSINESS:**

### 1. DISCUSS AWARD OF DRAINAGE CONTRACT.

City Administrator Brick said the city received 4 bids at the public opening. He said staff recommends awarding the bid to the lowest bidder Leimer Brothers Inc. in the amount of \$1,133,226.99. Mayor Pierson said Leimer was a local company and he was familiar with their work. He also said he wanted to give a special thanks to Rhonda Gregg for her help with the permit.

Ginger Jones, 16612 Curlew, inquired if the project was city-wide.

### 2. DISCUSS BEACH CLEANING FUNDS FOR EMERGENCY CLEANUP.

City Administrator Brick said the city received 2 bids for one-time beach cleanup. He said staff recommends A Green Expectations in the amount of \$3,840. Alderman Montgomery inquired about the status of additional trash pick-up and extra trash containers. City Administrator Brick reminded Council that it would cost \$600 for Saturday trash pick-up on the beach.

# 3. DISCUSS ALLOWING A SPECIAL USE PERMIT FOR SNOW CONE TRAILER ON THE BEACH.

City Administrator Brick said he received a request for a Special Use Permit from a Snow Cone Vendor to park on the beach. His recommendation is to defer the item until Planning and Zoning can meet to discuss the Special Use Permit. Sean Stowell, 16708 Fletcher Christian, attended the meeting to explain his request for the Special Use Permit; he provided Council with his proposal.

4. DISCUSS TRANSFERRING LEAP ENGINEERING CONTRACT TO LJA ENGINEERING.

City Administrator Brick he had not received the contract transferring Leap Engineering to LJA Engineering; he suggest deferring the item until the city receives the contract.

5. DISCUSS ORDERING THE CANCELLATION OF THE MAY 12, 2012 CITY OFFICER'S GENERAL ELECTION BY ACCEPTING A CERTIFICATION OF UNOPPOSED CANDIDATES FROM THE CITY SECRETARY. Mayor Pierson said he received a Certification of Unopposed Candidates from City Secretary Rushing stating 3 positions were open and 3 candidates applied. He thanked Alderman Sherwood Green for his 11 years of serving on Council.
