CALL TO ORDER

MPT Steve Spicer called the meeting to order.

1. DISCUSS SIGN AGREEMENT BETWEEN JBIC AND CITY OF JAMAICA BEACH.

City Administrator Brick explained the sign agreement between JBIC and the City of Jamaica Beach. JBIC has agreed to pay for the construction, installation and maintenance of the two entrance signs that read "Welcome to Jamaica Beach". Alderman Burke mentioned that JBIC worked really hard with TxDOT to get the signs approved.
