1. DISCUSS CANVASSING THE ELECTION RETURNS FROM THE MAY 5, 2018 CITY OFFICERS' GENERAL ELECTION.

Mayor Spicer and Council, sitting as the canvassing board to canvass the City Officers' General Election on May 5, 2018, certified that the following is a total of all votes received by each candidate as shown on the precinct returns; further certifying that the following vote totals include early voting votes by precinct received under Section 87.1231 of the Texas Election Code:

 - Alderman Welch motioned to approve the bid from Edwin Hidalgo for \$5,000 to install the memorial brick walkway at the city park with funding from the memorial brick fundraiser revenue and non-budget reserve park board fund. Second by Alderman Kurtz. Motion unanimously approved by those present.
