CITY COUNCIL REGULAR MEETING MINUTES

JUNE 15, 2020 6:00 P.M.

CALL TO ORDER

MPT Sherwood Green called the meeting to order.

- 1. CONSIDER FOR ACTION APPROVING THE FOLLOWING MINUTES:

Alderman Morris motioned to approve the above listed minutes. Second by Alderman Rupertus. Motion unanimously approved by those present.

- 2. CONSIDER FOR ACTION APPOINTING A MAYOR PRO-TEM.
 - Alderman Rupertus motioned to appoint Sherwood Green as the Mayor Pro-Tem. Second by Alderman Rizzo. Motion unanimously approved by those present.
- 3. CONSIDER FOR ACTION APPROVING THE ISSUANCE OF SEVEN (7) NEW PUBLIC FUND CERTIFICATES OF DEPOSIT (CDs) FOR THE CITY OF JAMAICA BEACH USING UNALLOCATED FUNDS IN THE GENERAL FUND AND MUNICIPAL SERVICES FUND CHECKING ACCOUNTS, AUTHORIZING THE CITY ADMINISTRATOR TO EXECUTE THE FUND TRANSFERS.

Alderman Kurtz-Hoffman motioned to approve the issuance of seven (7) new public fund certificates of deposit (CDs) for the City of Jamaica Beach using unallocated funds in the General Fund and Municipal Services Fund checking accounts, authorizing the City Administrator to execute the fund transfers. Second by Alderman Morris. Motion unanimously approved by those present.

Council reconvened in Open Session at 7:00 p.m. MPT Green noted no action was taken during Executive Session. Alderman Rupertus motioned to continue with the eminent domain process for the property located at 16730 Jamaica Beach Rd. Second by Alderman Morris. Motion unanimously approved by those present.

City Administrator Hutchison reported on the following: outdoor swimming pools may operate at up to 50% of normal operating limits per Executive Order GA-23; update on the city's waterline replacement project; update on the street improvement/County mobility project; Annual Hurricane Preparedness Meeting will be conducted via ZOOM; encouraged citizens to visit the city's Emergency Preparedness website page for periodic updates.
