# **ITEMS OF BUSINESS:**

- DISCUSS AND CONSIDER FOR ACTION ADOPTING A RESOLUTION IN SUPPORT OF THE APPOINTMENT OF DON MAFRIGE TO THE TEXAS WINDSTORM INSURANCE ASSOCIATION BOARD.
  - MPT Burke motioned to adopt a Resolution in support of the appointment of Don Mafrige to the Texas Windstorm Insurance Association Board. Second by Alderman Montgomery. Unanimously approved by those present.
- 2. CONSIDER FOR ACTION DECLARING PROPERTY AT 16715 TAHITI WAY & 16627 CAPT. KIDD IN VIOLATION OF CITY ORDINANCE 2010-1.
  - Member's of Council passed by the property located at 16715 Tahiti Way and did not notice any additional improvements since the last Council meeting. Alderman Montgomery motioned to declare both property's in violation of City Ordinance 2010-1. Second by Alderman Morse. Unanimously approved by those present.

- 4. CONSIDER FOR ACTION CREATING A JAMAICA BEACH SWIMMING POOL COMMITTEE WITH THE FOLLOWING MEMBERS: GENE MONTGOMERY, SANDY DENBY, JOHN BRICK, GAY FUNDLING, KEVIN HARPER, JAMIE PRUETT AND ROSEMARY LINDLEY.
  - Alderman Denby motioned to create a Jamaica Beach Swimming Pool Committee with the above listed member's. Second by Alderman Morse. Unanimously approved by those present.

City Administrator Brick inquired if all Councilmember's had a City ID card; informed Council the dirt fill at the Bird Sanctuary is permitted by the Corp of Engineer; City Hall renovations are progressing, but probably won't be complete until the end of July; he reminded everyone the final Beach Erosion Plan will be presented during the July  $2^{nd}$  Council Meeting which will start at 4:00 p.m. in the Fire Station.
