City Attorney Schulz attended the meeting to explain the City's legal options for filing against the homeowner's that are in violation of Ordinance 2010-1.

Ginger Jones, 16612 Curlew, said she was glad to see the City doing something about these houses.

Mayor Pierson said he was happy to see this item on the agenda. He explained the Bonds the City had in the past. He gave a brief explanation of the Waterworks and Sewer System Revenue Refunding Bonds, Series 1999. He said the bond is currently around \$705,000 with an interest rate of 5.5%; the bank account designated to pay one the bond has an annual interest rate of 0.35%. The bond is scheduled to be paid off in 2014; by redeeming the bond now the City would save over \$35,000 per year.
