CITY COUNCIL WORKSHOP MEETING MINUTES

OCTOBER 5, 2015 6:00 P.M.

CALL TO ORDER *Mayor Steve Spicer called the meeting to order.*

PLEDGES OF ALLEGIANCE TO THE U.S. AND TEXAS FLAGS

MPT Gene Montgomery led the Pledges of Allegiance to the U.S. and Texas Flags.

ROLL CALL OF ALDERMEN

ITEMS OF BUSINESS:

1. DISCUSS A VARIANCE REQUEST TO INSTALL AN A/C PLATFORM 4 FEET INTO THE SETBACK AT 4404 BOB SMITH.

Item Tabled until October 19, 2015 for lack of motion.

- 2. DISCUSS RENEWING THE CONTRACT FOR WATER POLLUTION CONTROL AND ABATEMENT WITH THE GALVESTON COUNTY HEALTH DEPARTMENT. City Administrator Brick explained the contract with the Galveston County Health Department for water pollution control and abatement; he noted the contract increased from \$1,000 to \$3,000 for services.
- 3. DISCUSS THE DESIGNATION OF REPRESENTATIVE AND ALTERNATE TO THE HOUSTON GALVESTON AREA COUNCIL 2016 GENERAL ASSEMBLY. Mayor Spicer noted the designation of a representative and alternate was an annual request from the Houston Galveston Area Council. After a brief discussion, Council agreed to designate Alderman Hudson as the representative and Alderman Rupertus as the alternate at the next Regular Called Council Meeting.
- 4. DISCUSS APPOINTING MATT MEADOWS AS A PARK BOARD MEMBER. Dave Voight, President of the JB Park Board, attended the meeting to recommend appointing Matt Meadows as a new Park Board Member.

5. DISCUSS AUTHORIZING THE FUNDING OF THE PARK BOARD HALLOWEEN EVENT HELD AT THE CITY PARK WITH MONIES TO COME FROM THE PARK BOARD FUND, AMOUNT NOT TO EXCEED \$1,000.

Taz Jones, Vice President of the JB Park Board, attended the meeting to provide details regarding the Halloween Event; she suggested the JBPD review the homes that sign up on the trick-or-treat list prior to the list being distributed.

6. DISCUSS AUTHORIZING THE FUNDING OF THE EMPLOYEE RETIREMENT PLAN ACCOUNTS.

City Administrator Brick noted the funding of the employee retirement plan accounts was a budgeted item.

7. DISCUSS AUTHORIZING CITY STAFF TO ADVERTISE FOR BIDS FOR THE BANK DEPOSITORY CONTRACT.

City Administrator Brick noted the current bank depository contract expires at the end of 2015; he is requesting Council to authorize city staff to advertise for bids.

8. DISCUSS AUTHORIZING CITY STAFF TO ADVERTISE FOR BIDS FOR THE CITY PARK PARKING LOT.

Mayor Spicer noted after numerous discussions with JBIC and residents, Council agreed to revise the city park parking lot plans to allow for more green area by reducing the amount of concrete parking. Jan Kreuger, 16618 Curlew, said she did not attend the Council Meeting that discussed the revised parking lot plans; she asked for a brief description of the revisions.

9. DISCUSS AMENDING ORDINANCE 2012-2 BY ADOPTING ORDINANCE 2015-3 TO EXTEND THE CURFEW FOR ANOTHER 3 YEARS.

City Administrator Brick informed Council the Curfew Ordinance expires every 3 years; Council would need to amend the Ordinance to continue a curfew for minors.

Ginger Jones, 16612 Curlew, inquired if the curfew only pertaining to minors.
