CITY COUNCIL REGULAR MEETING MINUTES

NOVEMBER 18, 2019 6:00 P.M.

CALL TO ORDER *Mayor Steve Spicer called the meeting to order.*

Alderman Rizzo motioned to approve an Interlocal Agreement for Water Supply with the City of Galveston, Texas and the City of Jamaica Beach, Texas, designating the City Administrator as the

MPT Green motioned to approve a Resolution casting the city's 5 votes to candidate Tom Farmer in the 2020-2021 Galveston Central Appraisal District Board of Directors Election. Second by Alderman Rizzo. Council briefly discussed selecting Bruce Clawson as another candidate. CONSIDER FOR ACTION AN ORDINANCE OF THE CITY OF JAMAICA BEACH, TEXAS TO ADOPT THE 2018 SERIES OF THE INTERNATIONAL BUILDING CODES: INTERNATIONAL RESIDENTIAL CODE WITH EXCEPTION TO SECTION R313 AND SECTION R309.5, INTERNATIONAL BUILDING PLUMBING CODE, CODE, INTERNATIONAL INTERNATIONAL FUEL GAS CODE, INTERNATIONAL MECHANICAL CODE, INTERNATIONAL FIRE CODE, INTERNATIONAL ENERGY CONSERVATION CODE; AND THE 2017 NATIONAL ELECTRICAL CODE WITH AN AMENDMENT TO STATE THE SMALLEST WIRE SIZE FOR RESIDENTIAL USE IS TO BE 12 GAUGE, INCLUDING AMENDMENTS, EXCEPTIONS AND SPECIAL JAMAICA BEACH REQUIREMENTS, RELATING TO INSPECTION ACTIVITIES OF THE CITY OF JAMAICA BEACH, GALVESTON COUNTY, TEXAS AND ENFORCEMENT OF BUILDING PROVISIONS AS PROVIDED IN SAID CODES.

Alderman Kurtz motioned to approve the above stated Ordinance. Second by MPT Green. Motion unanimously approved. Creating Ordinance 2019-8.

Alderman Morris reported his attendance at Officer Ornelas' benefit; he thanked his dad for being his best friend and for being an overall great person.
