ITEMS OF BUSINESS:

1. DISCUSS AWARDING BANK DEPOSITORY CONTRACT.

City Administrator Brick announced that the city only received two bids for the Bank Depository Contract. One was from Texas First Bank and the other was from Moody National Bank. He provided Council with a brief description of each bid. Moody National Bank offered the best rates for a one year contract. The city's recommendation is to award the contract to Moody National Bank for one year to see where the rates are after a year.

2. DISCUSS FUNDING EMPLOYEE CHRISTMAS BONUSES.

City Administrator Brick recommended to Council to approve employee Christmas bonuses. He explained that the city has funded Christmas bonuses for the last several years and that it is normally an extra paycheck. Alderman Morse said that she thinks the employees work hard all year and deserve the bonus.
