CITY COUNCIL SPECIAL CALLED MEETING MINUTES

DECEMBER 7, 2015 6:00 P.M.

CALL TO ORDER

Mayor Steve Spicer called the meeting to order.

PLEDGES OF ALLEGIANCE TO THE U.S. AND TEXAS FLAGS

Mayor Steve Spicer led Pledges of Allegiance to the U.S. and Texas Flags.

ITEMS OF BUSINESS:

1. DISCUSS AND CONSIDER FOR ACTION AWARDING THE BANK DEPOSITORY BID.

City Administrator Brick informed Council he received two bids: Moody Bank and Frost Bank; he recommends continuing the city's bank depository services with Moody Bank for 1 year.

Alderman Green motioned to award the bank depository contract to Moody Bank for a 1 year. Second by MPT Montgomery. Motion unanimously approved by those present.

2. DISCUSS AND CONSIDER FOR ACTION AWARDING THE CITY PARK PARKING LOT BID.

City Administrator Brick informed Council he received only 1 bid and it was from Lucas Construction; he noted Lucas Construction was the same company that did the City Hall parking lot. Council discussed the bid then the Mayor opened the discussion:

Terri Rizzo, 16502 Jamaica Inn, inquired if the previous bid included landscaping.

Ginger Jones, 16612 Curlew, asked what the price difference was between the original bid and the second bid submitted by Lucas.

Alderman Green motioned to Table the item until January. Second by MPT Montgomery. Motion unanimously approved by those present.

- 3. DISCUSS AND CONSIDER FOR ACTION A VARIANCE REQUEST TO INSTALL AN A/C PLATFORM 2 ½ FEET INTO THE SETBACK AT 16522 JAMAICA COVE.
 - Item withdrawn. No discussion, no action.
- 4. DISCUSS AND CONSIDER FOR ACTION AUTHORIZING THE EMPLOYEE INCENTIVE CHECKS.

Mayor Spicer noted item was a budget item. MPT Montgomery motioned to authorize the employee incentive checks. Second by Alderman Green. Motioned unanimously approved by those present.

5. DISCUSS AND CONSIDER FOR ACTION MAILBOX ROOFING AND REMODELING BY JBIC.

Council discussed item then the Mayor opened the discussion:

Margaret Lloyd, 16643 Bahama Way, spoke on behalf of JBIC, said JBIC consulted with Gil Madray to design the plans; they estimate the cost to be between \$13,000-\$15,000 for each structure. The plans were presented to Council for review and discussion. Alderman Rupertus motioned to Table until January. Second by MPT Montgomery. Motion unanimously approved by those present.
