

ORDINANCE NO. 77-1

AN ORDINANCE AMENDING ORDINANCE NO. 76-6 BY INCREASING
THE GENERAL PENALTY FOR VIOLATIONS OF VILLAGE ORDINANCES.

WHEREAS, the Village Council of the Village of Jamaica Beach deems it to be in the best interest of the health, safety, and general welfare of the citizens of the Village to increase the general penalty for violations of Village Ordinances where no specific penalty is provided therefore;

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF JAMAICA BEACH, TEXAS:

SECTION 1. That Ordinance 76-6 Section 1 shall be and it is hereby amended to read as follows:


SECTION 1. Whenever in any ordinance of the Village an act is prohibited or is made or declared to be unlawful or an offense or a misdemeanor, or whenever in such ordinance the doing of any act is required or the failure to do any act is declared to be unlawful, where no specific penalty is provided therefore, the violation of any such provision of any such ordinance shall be punished by a fine not exceeding \$200.00. Provided, however, if the maximum penalty provided by this Ordinance or any such offense is greater than the maximum penalty provided for the same or a similar offense under the laws of the State, then the maximum penalty for violation as provided by State Statute shall be the maximum penalty under this Ordinance. Each day any violation of any ordinance shall continue shall constitute a separate offense.


SECTION 2. All other terms and provisions of Ordinance No. 76-6, other than those specifically amended as hereinabove set forth shall remain unaltered and unchanged by this Ordinance and in full force and effect.

SECTION 3. That the hereinbefore recited ordinance be enacted as 77-1 of the Ordinances of the Village of Jamaica Beach, Texas.

SECTION 4. That this Ordinance shall be and become effective from and after its adoption and publication as required by law.


