

ORDINANCE 77-7

AN ORDINANCE ESTABLISHING THE CHARGE OF NEGLIGENCE COLLISION FOR ANY DRIVER OR OPERATOR OF A VEHICLE UPON ANY PUBLIC STREET OR HIGHWAY WITHIN THE CORPORATE LIMITS OF THE VILLAGE OF JAMAICA BEACH AND PROVIDING A PENALTY FOR VIOLATION THEREOF.

BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF JAMAICA BEACH, TEXAS:


SECTION 1. If any driver or operator of a vehicle upon any public street or highway within the Corporate Limits of the Village of Jamaica Beach shall, with negligence cause damage to or collide with any other vehicle of any kind whatsoever, or with any other property, resulting in a total damage, to an apparent extent of FIFTY AND NO/100 DOLLARS (\$50.00) or more, within the said Corporate Limits of the Village of Jamaica Beach, he shall be held guilty of negligent collision, and upon conviction shall be fined not less than FIVE AND NO/100 DOLLARS (\$5.00) nor more than TWO HUNDRED AND NO/100 (\$200.00).

SECTION 2. Proof of no intent on the part of any operator of any vehicle charged with an offense under this Ordinance to collide with any other vehicle or with any other property shall be no defense to any charge filed under the authority of such Ordinance.


SECTION 3. That the hereinbefore recited ordinance be enacted as 77-7 of the Ordinances of the Village of Jamaica Beach, Texas.


