

MARINA BOAT RAMP & PARKING PERMIT APPLICATION

The City of Jamaica Beach Regatta Basin ("Marina") facility features a single, stabilized, paved boat ramp with finger piers, parking area and seating area (no restrooms). All guests require a permit to launch, remove and/or park. Guest day use applications may be submitted by the resident via drop box at Jamaica Beach City Hall, or via email to cityadmin@jamaicabeachtx.gov. Please note that applications may take 1-2 business days to process. Permit fees are subject to change per City Council approval.

Terms of Use:

Before purchasing a permit for your guest, please read and understand the terms of use listed below.

- Residents/Property Managers may purchase a daily permit for the purpose of allowing a specific guest to use the boat ramp. Please note a daily permit is required for <u>each day</u> the ramp is used, not how long a watercraft is in the water. Resident is required to report guest info to City Hall prior to using the pre-purchased permit(s). Failure to remit information to City Hall will result in the permit being invalidated.
- Daily permits are \$10.00 per permit and are valid for one calendar day ONLY (date indicated on the hanging placard).
- Permit fees are non-refundable. Lost/stolen permits will not be reissued; new permit must be purchased.
- Daily permit must be hung on the vehicle's rearview mirror with the permit # and date facing the front windshield.
- NO commercial use. Permits will NOT be issued for commercial use of the boat ramp or parking area.
- Vehicles or trailers are not permitted to park at the Marina for more than (24) consecutive hours.
- Permit does not guarantee a parking space. Parking spaces are available on a first-come, first-served basis and are intended for boats that are in use.
- Unattached trailer or recreational vehicle parking not allowed.
- Parking on Basin Drive without a valid permit is prohibited.
- Parking your vehicle facing oncoming traffic is prohibited per the Texas Transportation Code 545.303.
- Violations of any of these terms may result in ticketing, towing at the owners expense, and/or revocation of permit per City Ordinance 2021-3.
- Permit holders that allow unauthorized users to access the marina, or that have unlawfully secured a permit for or shared a permit with an unauthorized user are subject to being charged with a misdemeanor offense holding a fine of no less than \$500.
- The City of Jamaica Beach has the right to close the boat ramp and/or parking area for good cause, including but not limited to maintenance and repairs or in the event of an emergency.

Hold Harmless/Indemnification Agreement:

I hereby assume the risk associated with the use of the Marina and agree to hold the City of Jamaica Beach, its agents, designees, employees, and elected officials free and harmless at all times from and against all claims, liability, expenses, losses, costs, fines, damages or causes of action of every kind and character, including attorney's fees and costs, whether at trial or appellate levels or otherwise, due to my acts, errors or omissions resulting in bodily injury, including death, or damage to my property or the property of others incident to or in connection with my use of the facility.

By signing, I hereby acknowledge that I have read and agree to abide by the terms, rules, regulations and laws governing the use of the Marina facility. I understand that failure to comply with these rules may result in a fine or civil penalty or the inability to obtain a boat ramp & parking permit.
